MUNDI, A 41-YEAR-OLD AFRICAN SAVANNAH ELEPHANT, WAS BROUGHT TO THE US WITH DOZENS OF OTHER CALVES FROM ZIMBABWE FOLLOWING A LARGE ELEPHANT "CULL" BY THE GOVERNMENT.
